INTRODUCTION

Please read this entire Acknowledgment and Assumption of Risks & Release and Indemnity Agreement (hereafter, 'Document') carefully before signing. All participants (including attending Organization students, employees, staff and representatives) must sign this Document. For participants under 18 years of age (hereafter sometimes 'minor' or 'child'), parents or guardians (hereafter collectively 'Parent/s') must also sign. In consideration of the services of Cheley Colorado Camps, Inc., and its agents, owners, officers, directors, employees, representatives and sub-contractors, (collectively referred to in this Document as 'Cheley'), I (participant, and Parent/s of a minor participant) acknowledge and agree as follows:

ACKNOWLEDGMENT AND ASSUMPTION OF RISKS

Educational, instructional, and/or adventure activities (which may be scheduled or unscheduled, mandatory or optional, supervised or unsupervised, and/or be led by Cheley staff or its sub-contractors, or Organization representatives) taking place on or off Cheley property may include, but not be limited to: hiking, technical rock climbing (both indoors on artificial walls, and outdoors on natural rock), route-finding, low element challenge course activities, fishing, interactive games and other sporting activities, and transportation in vans and other vehicles to and from activities (referred to in this Document as 'activities'). I acknowledge that the inherent and other risks, hazards and dangers (hereafter collectively 'risks') of these activities can cause injury (including mental or emotional trauma, paralysis or disability), damage, death or other loss to participant or others. Some, but not all of these risks include travel in high-altitude, mountainous or wilderness terrain; unpredictable and hazardous ground, water or weather conditions; close and unpredictable contact with wildlife; allergic reactions or injury from plants or insects; misjudgments or carelessness of Cheley staff, sub-contractors, co-participants or others; and equipment that can fail or malfunction. I understand that Cheley cannot assure participant's safety or eliminate any of these risks. During both supervised and unsupervised activities, all participants share in the responsibility for their own safety, and agree to obey all Cheley rules and policies. Participant is voluntarily participating with knowledge of the risks, and Parent/s of minors give permission for the minor to participate in any and all activities. **Therefore, participant (and Parent/s of minors) assumes and accepts full responsibility for the inherent and other risks (both known and unknown) of these activities and for any injury, damage, death or other loss suffered by participant (and Parent/s of minors), resulting from those risks and/or resulting from participant's negligence or other misconduct.**

RELEASE AND INDEMNITY AGREEMENT

Please read carefully. This Release and Indemnity Agreement contains a surrender of certain legal rights. I (adult participant, or Parent/s for themselves and for and on behalf of their participating minor child) agree as follows:

- 1. to release and agree not to sue Cheley** in regard to any and all claims, liabilities, suits or expenses (including attorneys' fees and costs) (hereafter collectively 'claim' or 'claims') for any injury, damage, death or other loss in any way connected with my/my child's enrollment or participation in these activities, or use of Cheley equipment, facilities and/or premises. **I understand that in signing this Document, I, my child, and anyone acting on my or my child's behalf, surrender our respective rights to make a claim against Cheley as a result of any injury, damage, death or other loss suffered by me or my child;**
- 2. to defend and indemnify** ('indemnify' meaning protect by reimbursement or payment) **Cheley** in regard to any and all claims brought by or on behalf of me, a family member, a co-participant, or any other person for any injury, damage, death or other loss in any way connected with my/my child's enrollment or participation in these activities or use of Cheley equipment, facilities and/or premises.

This Release and Indemnity Agreement includes any claims caused or alleged to be caused, in whole or in part, by the negligence (but not the willful, wanton or criminal misconduct) of Cheley and includes claims for personal injury or wrongful death (including claims related to emergency or medical response, assessment or treatment), property damage, loss of consortium, breach of contract or any other claim.

CONCLUSION

I (participant and Parent/s of a minor participant) agree that the substantive laws of Colorado (without regard to its 'conflict of laws' rules) govern this Document, any dispute I have with Cheley and all other aspects of my relationship with Cheley, and that any mediation, suit or other proceeding must be filed or entered into only in Larimer County, Colorado. I agree to attempt to settle any dispute (that cannot be settled by discussion) through mediation before a mutually acceptable Colorado mediator. I authorize Cheley staff, representatives or other medical personnel to obtain or provide medical care for me/my child, to transport me/my child to a medical facility, and to provide treatment they consider necessary for me/my child's health. I agree to pay all costs associated with that care and transportation (including any evacuation). I authorize Cheley to use my or my child's photo or image in any manner, for advertising, display, electronic or other use. **This Document is intended to be interpreted and enforced to the fullest extent allowed by law. If any portion of this Document is deemed unlawful or unenforceable it shall not affect the remaining provisions, and those remaining provisions shall continue in full force and effect.**

Participant and Parent/s of a minor participant agree: I have carefully read, understand and voluntarily sign this Document, and acknowledge that it shall be effective and binding upon me, my minor children and other family members and my heirs, executors, representatives and estate. **One or both Parent/s must sign below for if participant is under 18 yrs. of age.**
